CapitaCommercial Trust Management Limited, as manager (the "**Manager**") of CapitaCommercial Trust ("**CCT**"), wishes to announce that S\$14,500,000 in aggregate principal amount of S\$225,000,000 2.7 per cent. convertible bonds due 2015 (the "**Convertible Bonds**") have been converted and cancelled. This is due to an exercise of conversion rights by the holders thereof.

Together with the current conversion, the total principal amount of **Convertible Bonds** converted and cancelled up to the date of this announcement is S\$67,250,000. Following the conversion and cancellation, the aggregate principal amount of **Convertible Bonds** remaining outstanding as of 13 June 2014 is S\$157,750,000.

Arising from the current conversion, 12,158,309 new **Units** in **CCT** have been issued at the conversion price of S\$1.1926 per **Unit**, and the total **Units** in issue is 2,910,225,894.
