#### **PAYMENT OF BASE COMPONENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN CAPITALAND INTEGRATED COMMERCIAL TRUST**

---

CapitaLand Integrated Commercial Trust Management Limited (the “**Company**”), as manager of CapitaLand Integrated Commercial Trust (“**CICT**”), wishes to announce that 2,964,337 units in CICT (“**Units**”) have been issued today at an issue price of S\$1.9315 per Unit to Premier Healthcare Services International Pte Ltd (“**Premier**”), an entity nominated by the Company to receive the 2,964,337 Units in its place<sup>1</sup>. The issue price per Unit is based on the 10-business day volume weighted average price per Unit for all trades done on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the period from 20 March 2023 to 31 March 2023 (both dates inclusive), in accordance with the trust deed dated 29 October 2001 constituting CICT (as amended from time to time).

The abovementioned Units have been issued as payment of 50.0% of the base component of the management fee for the period from 1 January 2023 to 31 March 2023 (both dates inclusive) in relation to the management of investments (including properties) that are held by CICT and/or its subsidiaries<sup>2</sup>. The remaining 50.0% of the base component of the management fee will be paid in the form of cash.

With the abovementioned issue of Units, the total number of Units in issue is 6,651,581,945. As the Units have been issued to Premier, the total number of Units held by the Company is 58,899,377<sup>3</sup>.
