ANNOUNCEMENT

PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN CAPITALAND INTEGRATED COMMERCIAL TRUST

CapitaLand Integrated Commercial Trust Management Limited (the "**Company**"), as manager of CapitaLand Integrated Commercial Trust ("**CICT**"), wishes to announce that 15,636,808 units in CICT ("**Units**") have been issued today at an issue price of S\$1.9258 per Unit to Premier Healthcare Services International Pte Ltd ("**Premier**"), an entity nominated by the Company to receive the 15,636,808 Units in its place¹. The issue price per Unit is based on the 10-business day volume weighted average price per Unit for all trades done on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the period from 17 December 2024 to 31 December 2024 (both dates inclusive), in accordance with the trust deed dated 29 October 2001 constituting CICT (as amended from time to time).

The abovementioned Units have been issued as payment of (a) 50.0% of the base component, and (b) 50.0% of the performance component, of the management fee for the period from 1 October 2024 to 31 December 2024 (both dates inclusive) and for the period from 1 January 2024 to 31 December 2024 (both dates inclusive) respectively, in relation to the management of investments (including properties) that are held by CICT and/or its subsidiaries². The remaining 50.0% of the base component, and 50.0% of the performance component, of the management fee will be paid in the form of cash.

Following the abovementioned issue of Units, the total number of Units in issue is 7,314,106,571. As the Units have been issued to Premier, the total number of Units held by the Company is 71,647,856³.

² This excludes CICT's 45% effective interest in each of Glory Office Trust and Glory SR Trust, which collectively hold CapitaSpring.

³ This takes into consideration 59,229 Units transferred from the Company's unitholding to its non-executive directors to satisfy the part payment of directors' fees in Units for the year ended 31 December 2024 and 606,501 Units transferred from the Company's unitholding to its key management personnel and eligible employees under the Company's Restricted Unit Plan and Performance Unit Plan.
