CLA Real Estate Holdings Pte. Ltd. ("CLA") owns 100% of CapitaLand Group Pte. Ltd. ("CLG"). CLG owns 53.93% of CapitaLand Investment Limited ("CLI").

Pyramex Investments Pte Ltd, Albert Complex Pte Ltd, Premier Healthcare Services International Pte Ltd, SBR Private Limited, CICTML, and Carmel Plus Pte. Ltd., which collectively own 20.01% of CICT units, are wholly owned subsidiaries of CLI.


CLG is a majority shareholder of CLI and therefore, CLG is deemed to have an interest in the units of CICT in which CLI has an interest by virtue of Section 4 of the Securities and Futures Act 2001.

CLG is a wholly owned subsidiary of CLA and therefore, CLA is deemed to have an interest in the units of CICT in which CLG has an interest by virtue of Section 4 of the Securities and Futures Act 2001.
